- i. Eligible applicants will appear in Written Test of 80 marks.
- Individual admit card of eligible candidates having date, time and address of the written ii. examination center will be sent by post.
- The written examination will have objective type Multiple Choice questions and the distribution of iii. a. English: 20 marks

b. Arithmetic:

20 marks

c. General Awareness:

20 marks

- d. Job specialization oriented: 20 marks
- The successful candidates on the basis of marks obtained in the written test will be called for iv. ٧.
- Candidates who succeed in the Computer Test will, in the ratio of 1:5, will be called for Viva Voice Test carrying 10 marks.
- The Selection Committee will submit the merit list of successful candidates in the ratio of 1:4 to vi. the District Child Protection Society / Unit for approval and appointment. vii.
- The list will be valid for 2 (two) years from the date of approval of the list by the DCPS / DCPU. viii.
- Police Verification and Medical examination of the contractual person will be done after joining.

- No TA & DA is admissible for attending Written / Computer / Viva examination. ix.
- If at any stage, after the issue of admit card, a candidate if found to be ineligible for admission to X. the examination in terms of the advertisement his/her candidature will be cancelled without further reference to him/her.
- Candidates who knowingly or willfully furnish incorrect or false particulars or suppress information xi. will be disqualified, and if appointed, will be liable to termination of service.
