2. CONTRACT PERIOD:

For Counselor FLCC

3. CONTRACT AMOUNT AND OTHER TRAVELLING EXPENSES:

For FLCC Counselor and Faculty RSETI:

The contract amount shall be paid an amount equivalent to last pay & allowances drawn less the initial amount of pension fixed before commutation plus relief etc. payable thereon or Rs.15000/- p.m. whichever is lower for FLCC Counselor and For Faculty RSETI- Rs.20000/- P.M whichever is lower.
