ELIGIBILITY

REMUNERATION

The selected candidate will be paid consolidated remuneration @ **Rs. 25910/-** per month (Rs. Twenty five thousand nine hundred and ten only). No other allowances/benefits will be admissible other than consolidated remuneration.

AGE LIMIT:
