Duties of each PLV's shall be to educate people particularly those belonging to weaker sections of the society, of their rights given by the constitution, assisting GSLSA/DLSA/TLSC for organizing legal awareness camps, reporting violation of child rights, missing children, child labour and trafficking of girls children to concerned authorities, visit jails, police stations, lockups, psychaiatric hospitals, children's homes with proper authorization from the appropriate authorities and as laid down in the scheme for Para Legal Volunteers.

The Candidate shall type the relevant details in the format itself and remove the printout by downloading the above format and after the same is duly signed, submit the same addressing to the Hon'ble Chairman, District Legal Services Authority, South Goa, Margao along with the self attested documents as required on or before **20.04.2024** as the case may be.
