The Institute invites online application for the following position from candidates having Indian Citizenship and possessing excellent academic background, commitment to quality teaching and potential for carrying out outstanding research or an engineer/technologist of repute from industry or R&D laboratories for the Department of Metallurgical and Materials Engineering. The Institute also reserves the right to invite application through nomination basis or select the candidate through the Search-cum-Selection Committee.

Post: Tata Chair Professor – 01 (One) Post

Period of appointment and duration of the Chair: The appointment shall be made on contract basis for a period of one academic session (*i.e., July to next April*) extendable for a further period of one more semester/session.

Qualifications & Experience:

1. As per regular Professor of the Institute as under in relevant discipline:

Ph.D. with first class or equivalent at the preceding degree in the appropriate branch with a very good academic record throughout with a minimum of 10 (ten) years teaching / research / industrial experience of which at least 4 (four) years should be at the level of Associate Professor in IITs, IISc Bangalore, IIMs, NITIE Mumbai and IISERs or at an equivalent level in any such other Indian or foreign Institution(s) of comparable standards.

OR

2. An eminent academician/scientist/engineer/technologist/industry expert in the relevant areas, whom the Institute feels is well-suited to meet the goals of the post.

Age: Up to 70 years.

Emoluments:

1. Consolidated remuneration of Rs. 3,30,300 (*Rupees Three Lakh Thirty Thousand Three Hundred*) per month. However, in case of retired personnel, the remuneration shall be fixed as per Government of India norms considering the pension amount, if any.

OR

2. A top up of Rs. 25,000 (*Rupees Twenty-Five Thousand*) per month shall be given for existing Professor of the Institute in addition to the salary drawn from the Institute.

Residential accommodation: The Institute shall provide accommodation subject to availability. License fee, water charges, electricity charges and charges for any other services rendered shall be recovered as per statutes and rules framed thereunder.

Medical facility: OPD medical facility for self and dependent family members at B.C. Roy Technology Hospital, IIT Kharagpur.

Other facility: The Institute will provide the office space in the Department alongwith telephone and internet connectivity etc.

Role of the Appointee: The Chair Professor will be attached to the Department of Metallurgical and Materials Engineering or any other Department/Centre/School as decided by the Director of the Institute from time to time. Duties and responsibilities of the Chair Professor shall be the same as for a regular Professor of the Institute. The Chair Professor is expected to teach and to do research in his/her field of specialisation. The Chair Professor shall also work as a resource person for bringing sponsored research and industrial consultancy jobs to the Institute. The Chair Professor shall also perform such other duties assigned by the Director of the Institute. The Chair Professor shall devote the whole time to the service of the Institute and shall be subject to the general conduct and discipline rules applicable to all IIT employees under the Acts and Statutes of IIT.
