3	Location	Depending on the requirement of various projects of KRCL, transferable to any of KRCL Project sites as per requirement.

5	Period of re-employment	Initially, for a period of 2 years or until the completion of the Project, and extendable thereafter on a year-to-year basis on satisfactory performance and mutual consent.

9	Work Experience	Experience involving alignment design, survey, investigation, preparation of Detailed Project Report, Preliminary Engineering cum Traffic Survey, co-ordination with designers and proof checkers, planning, estimation, BOQ, execution of works, preparation of Tender documents, Invitation of Tender and its finalization, Contract Management of railway/road projects. Experience in execution of railway projects will be preferred.

[!] Medical Facility :

Re-employed personnel who join KRCL after 55 years of age and their family members will be entitled to reimbursement of premium of any recognised insurance company subject to upper ceiling limit of Rs. 1350/- per month, i.e. Rs. 16,200/- per annum for self and family together for indoor treatment. The reimbursement will be made on production of the original receipt.

For outdoor treatment, Re-employed personnel will be eligible for re-reimbursement of maximum of Rs. 1500/- per month or actual upon submission of necessary medical bills / vouchers with the copy of prescription.


Re-employed personnel will not be entitled for any medical facility from medical department of Konkan Railway, as re employed person.
